

On September 15<sup>th</sup> we held a virtual RMC Board of Directors meeting to conduct Chapter business. Some of the items discussed are outlined in the various reports included in this newsletter. One item discussed was regarding the Chapter going forward with hosting a Regional event in 2021 or 2022. The Loveland Embassy Suites was holding a date for us in 2021 and we needed to get back to the hotel if we wanted to go forward with hosting a Regional next year. After lengthy discussion, including the continued uncertainty with regard to COVID-19 and the timing of when our daily lives will be less restricted with regard to social gatherings, the Board of Directors decided, unanimously, to not go forward with hosting a Regional in 2021 or 2022. ## 2021 Rocky Mountain Road Tour Update



## NCRS Rules & Regulations for Events in the COVID-19 Era

### Introduction

This document contains the rules and regulations that N. C. R. S., Inc., ("NCRS") has established for running its events while the threat of COVID-19 pandemic infection exists. These rules and procedures must be followed at all in-person NCRS events until such time that NCRS determines that they no longer need to be followed.

If the United States CDC or another branch of the US federal government, a host state government, or a local host government, or a private host facility has rules and regulations in place that are more stringent than the rules and regulations in this document, those rules and regulations must be followed in addition to these NCRS rules and regulations.

In the event that the United States CDC, another branch of the federal government, a host state government, a local host government, or a local host facility has rules and regulations in place that are less stringent than the rules and regulations in this document, then the rules and regulations outlined in this document are to be followed.

In many situations, NCRS will require six-foot (6') social distancing and/or use of face coverings to minimize the potential for transmission of COVID-19.

To the extent that these requirements go beyond federal, state, or local PPE requirements at the time of the event, NCRS will bear the entire cost of extra PPE items/supplies required to comply with these rules and regulations at all regional and national events. NCRS will provide such PPE items/supplies to chapters at cost for use at chapter events.

NCRS has created these rules and regulations to promote the following:

- To protect the health of NCRS members, guests and event attendees
- To create safe environment for NCRS events
- To allow NCRS events to proceed without undue burdens
- To protect the integrity of NCRS awards
- To continue the collegiality of NCRS

### Conduct During Judging Meets

NCRS judging will be completed in the normal fashion, subject to the following requirements:

- Please make best efforts to observe 6' social distancing whenever owners, judges, observer judges and others are in the vicinity of any car being judged.
- Because social distancing cannot always be achieved when a car is being judged, all people in the vicinity of the judged car must utilize a face mask or face shield. Host Chapters must have disposable face masks available for judges who need them.
- Judges must use disposable medical-type gloves at all times while judging a car, such gloves must be discarded when judging of each car is completed. Host Chapters must have disposable medical-type gloves available for judges.
- To further minimize the chance of cross-contamination, judges are encouraged to wash their hands, or use CDC-approved hand sanitizer (i.e., >60% ethanol or 70% isopropanol alcohol) immediately after the completion of judging each car.



- Do not share pencils, manuals or clipboards during judging. Pencils will be discarded or sanitized after use by a judge or owner, and clipboards will be sanitized between uses.
- The car owner shall be the only person to touch the car or components of the car with ungloved hands.
- All persons entering or remaining in the show hall (or show field) shall utilize a face mask or face shield.
- These requirements shall apply to the show hall or show field, including operations check .

#### The Tabulation Department

The NCRS Tabulation Department receives score sheets for all cars, which, by definition, have been handled by many persons before the sheets arrive in the Tabulation Office. Accordingly, the following will apply:

- The tabulation work stations will be laid out to best accomplish social distancing.
- All tabulators must utilize a face mask or face shield while in the Tabulation Office.
- Tabulators may elect to use disposable medical-type gloves when present in the Tabulation Office. All gloves to be discarded upon leaving the Tabulation Office.
- No sharing of pencils or calculators; pencils will be discarded or sanitized after each day and calculators will be sanitized between uses. Pencils and calculators will be assigned to an individual tabulator for the duration of the work shift. Tabulators will be encouraged to bring their own supplies.
- Tabulation workers must wash their hands or use CDC-approved hand sanitizer immediately before entering and immediately after leaving the Tabulation Office.
- CDC-approved hand sanitizer must be available in the Tabulation Office.
- Disposable face masks must be available in the Tabulation Office

#### The Registration Desk

- All Registration Desk workers must attempt to achieve social distancing.
- All Registration Desk workers must utilize a face mask or face shield while present at the Registration Desk.
- All Registration Desk workers must use disposable medical-type gloves.
- Any person that approaches the Registration Desk must utilize a face mask or face shield while in the vicinity of the Registration Desk.
- CDC-approved hand sanitizer must be available at Registration Desk.
- Disposable face masks must be available at Registration Desk.

#### Judging Schools and Other Meetings

- Seating should be arranged to allow for 6' social distancing.
- All participants must utilize a face mask or face shield when entering the meeting room.
- If the entire meeting room has been arranged so that 6' social distancing is present throughout the entire room, attendees may remove their face mask or shield while seated (the mask or shield must be reinstalled when the person leaves his/her seat).
- If the entire meeting has not been arranged so that 6' social distancing is present, attendees must wear face masks or shields at all times while in the meeting room.

#### The Trailer Parking Lot and Other Parking Lots

The same rules and regulations as applied to the Registration Desk shall apply to all parking lots.

#### The Awards Banquet or Ceremony

For an Awards Banquet:

- Table service only, servers to wear face coverings. No buffet service.

- The banquet hall shall be laid out so that no person at one table is closer than 6' to any person at another table.
- There shall be no more than six persons seated at any table.
- All persons entering the banquet hall shall utilize a face mask or shield at least until that person arrives at his/her table seat.
- Once seated at his/her table, the person may remove his/her mask/shield while seated at that table (the mask or shield must be reinstalled when the person leaves his/her seat).
- No visiting with other tables once seated.
- The award presenter must take steps to ensure that no award has been touched by ungloved hands within the 48 hours preceding the banquet.
- The award presenter must use disposable medical-type gloves while presenting awards.
- The award presentation area must be created such that the presenter and recipient are never closer than 6'.
- No handshakes, but photographs with 6' social distancing may occur.

For an Awards Ceremony with no meal served:

- Utilize the same rules as above, but eliminate those rules that apply to food service and, perhaps, to seating.
- All attendees must observe social distancing and/or utilize a face mask or shield.

#### Judges & Tabulators Meals

For judges and tabulators meals:

- Table service or box lunches only, servers to wear face coverings. No buffet service.
- The judges and tabulators meal area shall be laid out so that no person at one table is closer than 6' to any person at another table.
- There shall be no more than six persons to be seated at any table.
- All persons entering the judges and tabulators meal area shall utilize a face mask or shield at least until that person arrives at his/her table seat.
- Once seated at his/her table, the person may remove his/her mask/shield while seated at that table (the mask or shield must be reinstalled when the person leaves his/her seat).
- No visiting with other tables once seated.

#### Any Portion of an Event not Covered Above

If there is a portion of an NCRS Event that is not covered by the above rules and regulations, remember that social distancing, face coverings and frequent hand washing are the keys to minimizing the chances of spreading COVID-19. If you remember these three items and employ them whenever necessary, you will be contributing to the effort to have an event that is as safe as it reasonably can be.

26<sup>th</sup> ANNIVERSARY CELEBRATION Over Labor Day weekend, some 340 registrants celebrated the Museum's 26th anniversary event. Regrettably this was my first absence in 13 years, but I'm glad to pass along to you these highlights.

GM C8 PRESENTATION On Friday, Tad Juechter and Harlan Charles provided a virtual on-screen seminar in the Chevrolet Theatre and for virtual viewers. The presentations included a review of the awards received by the C8, features of the 2020 Corvette, and a video demonstrating the convertible's new hardtop operation and equipment. Harlan provided a list of accessories for the C8 and an instructional video, one of 23 that GM has prepared on the C8.

Both Tadge and Harlan gave updates on *what is new for the 2021 Corvette*. The topics included the Magnetic Ride Control, wireless phone connection inside the cab, the Driver Mode Selector, and colors and stripes options. Harlan described the two new exterior colors, Silver Flare as having a 'lot of travel' and looking very different as you walk around the car and Red Mist as a 'fiery,' brighter than some of Corvette's previous red colors. Harlan and Tadge indicated the very first 2021 validation cars are in the process of being built, Silver Flare first and Red Mist fourth, so seeing full-car color is forthcoming. These pre-production cars will give the team a few months to check them out before building customer cars.

Several answers to questions were of keen interest. The 2020 model production will continue almost to the end of the year. Not all orders will be completed and those who have orders pending, will get the 2021 model. They must check with their dealer to re-order as the 2020 order will not carry over. The dealer should know the status of the orders.

When questioned on tires, Tadge advised that the new Michelin High Performance All Season tires are "state of the art," and different than previous A/S tires offered; they are not for track use!

ASSEMBLY PLANT UPDATE Kai Spande, Bowling Green's Corvette Assembly Plant manager gave a live presentation in the Chevrolet Theatre. After discussing Covid 19 implications on the plant, he launched into the topic of demystifying the codes between order dates and production schedules. The codes begin with #3000 (approved to be built and accepted by the plant's Production Center) and end with #4200 (Corvette shipped).

There are restrictions within the plant on assembling coupes and convertibles. It takes more time to install a convertible hardtop, as there are more parts; therefore convertibles are not built back to back. Corvettes are not assembled in batches such as 100% coupes followed by 100% convertibles. This and other

restrictions account for Corvettes not being assembled in sequence after the order has been approved to be built and accepted by the Production Center, which schedules the assembly sequence. Additional assembly plant internal codes were demystified, followed by a discussion on the Quality Control tests conducted on the Corvette before release from the factory.

Plant tours will not be available until the virus threat “goes away”. Kai’s main concern is for plant workers safety, therefore visitors are not permitted. Corporate must also approve visitations to the assembly plant before the tours resume.

Once visitors are approved, Kai advised that those selecting the option of observing their Corvette being built to drink lots of coffee or ‘Red Bull’ due to a second shift being added recently.

During the Plant update, Kentucky Senator Mike Wilson presented Kai Spande with a Senate Resolution recognizing the Corvette team for their successful launch of the next generation Corvette, and celebrating Corvette named North American Car of the Year! The resolution in part says: *Be it resolved members of the Senate...recognize the honor bestowed on General Motors...with this award, and congratulate GM in the design of the new Corvette Stingray.* Corvette was previously honored with this award in 1998 for the fifth-generation model, and again in 2014 for its seventh-generation model.

At the conclusion of his presentation, Kai revealed painted panels showing the two new 2021 colors: Red Mist Metallic Tintcoat and Silver Flare Metallic. Well received!

**GEORGE JONES' CORVETTE** NCM unveiled a newly acquired Corvette, the first celebrity-owned car to join its collection. The 1978 two-tone, special-ordered by country music singer George Jones because he liked the Pace Car look, features a one-off paint scheme of Corvette Dark Brown and Corvette Light Beige. His Vette sports an autographed dash and Jones' Tennessee plate reading NO SHOW. Asked if owning a Corvette affected his decision to cut *The Corvette Song* Jones replied, ‘Oh, absolutely!’ The car was acquired thanks to the generosity of Lifetime Members Lon and Anne Helton of Nashville, TN, and Tim and Donna Vincent of Broussard, LA.

NOTES I achieved Master Ambassador status again for 2019. Thanks Rocky Mountain Chapter for your support of the Museum... it’s an honor to serve as RMC’s NCM Ambassador!
