Penetrating oils ...... Average torque load to loosen

No Oil used . WD-40 ..... PB Blaster ... Liquid Wrenc Kano Kroil ... ATF\*-Acetone

The ATF-Acetone mix is a "home brew" mix of 50 -50 automatic transmission fluid and acetone. Note this "home brew" released bolts better than any commercial product in this one particular test. Our local machinist group mixed up a batch and we all now use it with equally good results. Note also that "Liquid Wrench" is almost as good as"Kroil" for about 20% of the price. Steve from Godwin-Singer says that ATF-Acetone mix is best, but you can also use ATF and lacquer thinner in a 50-50 mix.

\*ATF=Automatic Transmission Fluid



In the last newsletter I retrieved the archive of "Rattle-Can Tips" from Bill Lucia. This issue is a copy from the archives that was originally published in the Long Island Chapter newsletter. I have tried the ATF-acetone on my 98 Ford Truck and it still broke the bolt! ED

The magazine reports that they tested penetrates for break out torgue on rusted nuts. They are below, as forwarded by an ex student and professional machinist. They arranged a subjective test of all the popular penetrates with the control being the torque required to remove the nut from a "scientifically rusted"

I attended the event, August 31 -September 2, and photographed some of the exhibits. I am including 7 photos of the Carl Casper exhibit and 3 photos of the American Love Affair: 70 years of Corvette, along with information accompanying the exhibits. Rather than repeating here, you can read the details of both exhibits in the 3rd Quarter issue.

## CARL CASPER EXHIBIT:

## CUSTOM CARISMA

Created by Bob Kane and Bill Finger, Batman debuted in 1939, first appearing in Detective comics #27. Batman has become one of the most iconic and recognizable characters in popular culture. Possessing no superpowers, he instills fear in the hearts of criminals, taking the look of a bat!

Warner Brothers tasked Carl to build 3 long, low, sleek and highly sculptured Batmobiles for the movie. Loaded with dozens of crimefighting devices, this CORVETTE powered Batmobile proves to be one of the World's most popular of all Batmobiles.











Turbo Shark Carl Caper has always had an affection and admiration for Corvette, has owned many over the years and built two Corvette inspired creations. Carl began his work on the Turbo Shark starting with a 1964 convertible, unveiling it to the world in 1966. Auxiliary power was added to the 327 ci. 300 HP engine with an experimental Turbonique monopropellant turbine running on Thermolene and oxygen fuels. At maximum output, the supplemental supercharged turbine rotor hit 92,000 rpm while raising the HP to 700.

Turbo Shark's Ruby-Red plexiglass was hand blown to form the bubble top. The brilliant diamond dust pearlescence under the body's base paint was highlighted with a custom-blend ruby red translucent acrylic lacquer.

Renegade Duece The 1932 Ford sedan had been heavily used and abused. The sedan needed a lot of work and 47 years passed before Carl began to create the Renegade Duece. The body received extensive modifications. The 283 Corvette engine that had patiently sat for all those years fired right up to "hit the road" as soon as it was installed. It still had the Corvette Duntov camshaft.

## Cosmic Invader

In the 1970s, Carl answered the air pollution and oil crisis problems with an electric car, the "Cosmic Invader". Carl created, designed and built the concept vehicle on his own. While the automobile manufacturers were not open to teaming up with Carl, his creation received a great response at automobile shows.

The Cosmic Invader is powered by an 108 volt electric motor. The three-wheeled chassis was custom fabricated under a body designed and built by Carl Casper.

The exhibit, located in the new upgraded Skydome, is a walk through time, including cars from the early design eras to the Corvettes that collapsed into the sinkhole in 2014.
