Preferably a team of two for each section times four categories for a total of 40 judging personnel preferably more. Steve Steffensen tells me that he is considerably short and can use your services. Tabulation is another area of the judging that needs personnel to help out, this will aid in quick turn around of score sheet tabulations.

The members from our Chapter have not step up to help complete the teams and support personnel required for our meet.

The Judging field as I am told will consist of the following Corvette categories in the four judging classes. Solid axle category, 1953 – 1962:

There is a 1957 and a 1958 Corvettes with three master judges and their assistants.

Early Mid Years category, 1963 – 1964:

There are two 1963 and one 1964 Corvettes with a single master judge and his assistants.

Late Mid Year category, 1965 – 1967:

There is a 1965, a 1966 and a 1967 Corvettes with five master judges and their assistants

Shark Category 1968-1978:

There is a 1968, a 1972 and a 1978 Corvettes with three master judges and their assistants.

Well, a few more weeks have gone by and I was asked to put out a Newsletter to be sure to inform all the members of the up coming Heart of Ohio NCRS Chapter meet Saturday, September 11th, 2004. Your help is still needed so, Please give Steve Steffensen a call.

I have a few more updates to inform you about.

First, I have made updates to the Heart of Ohio Chapter's web site. This includes the posting of the Chapter's Newsletter, the Calendar updated schedule, and the Photo album. TO the Photo Album section I added photos from the Judging class held on August 7th. My intention is to reconstruct the original master template to maintain its structure when updates are put in. Anyway, more of web site updates due in the coming months.

Second, I have created a mailing list service for all members to use. This is a service that is available through our web site provider but must be maintained by the Heart of Ohio Chapter webmaster/postmaster. The service is to allow members to mail to a single address and this mail service will disseminate the message to all Chapter members. So, if you wish to mail to the Chapter members a notice, then you would mail to hoomembers@heartofohio-ncrs.com for all to read. However, if you reply back to this message, you will only reach the originator of the message. That is, if you wish all to read your response, then you need to mail back to hoomembers@heartofohio-ncrs.com to reach all once again. Only Chapter members are allowed posting messages to this listing service. The list service is setup this way to deter spam mailings.

Third, I have also setup a list service for board members. This list service is setup, at this time, to allow only board members to communicate to each other. So, to the general member if you wish to reach all the board members, you will need to include all the members in the mailing to address. Or, you could mail to one member and ask that the board member to rely this message to the board members.

I am also currently working on establishing contact with our clothing vendor to obtain more clothing items. More on this later.
