### Chapter Meeting Notes:

Our April Chapter Meeting was held the Thursday evening April 14<sup>th</sup> at Byer's Dublin Chevrolet. The subject was a tech seminar on the new Corvette 2005 C-6 and our host was Mark Wiese. Mark handles Sales and Leasing and can be reached at 614/793-4800, email [markwieseii@cs.com](mailto:markwieseii@cs.com).

Mark greeted us at 6:30 and graciously provided sandwiches and beverages knowing that we were probably going to miss dinner. Thirteen HoO members attended. In order to learn more about the group before giving his presentation Mark asked how many of us owned Corvettes. He was probably surprised to learn that, not only did we each own a Corvette; many of us owned several. In fact, it was estimated that among the 13 of us in attendance we probably owned between 50 and 75 Corvettes including six to ten C-5's!

Mark told us that his introduction to and training in the new C-6 came at a GM Dealer Introduction held at Road Atlanta. Each of the attendees had the opportunity to drive, on an inside track, not only the C-6 but several competing car makes as well. Obviously it was a great experience and gave him a real feel about how this Corvette compares to both its competitors and the C-5.

The subject car for the presentation was a blue C-6 coupe with a manual transmission. It was a beautiful car and well equipped with the most popular options. Mark went

over the features of the C-6 and discussed many of the innovations and the reasoning behind them. During his presentation we had the opportunity to ask many questions and Mark was most helpful in answering them. One thing we did learn, and something not obvious from many of the press releases, is that the C-6 has 17 different on-board computers that monitor and control many functions. Several of these computers are always on, regardless of whether the car is in use or not. And, if the car has a manual transmission, unless the shifter is left in reverse, these computers are always on and can drain a parked car's battery very quickly.

After the completion of Mark's presentation we all had an opportunity to sit in the C-6 and experience its comfort. And it was very comfortable. Unfortunately, Byer's policy does not allow for test drives without a signed purchase agreement but it was, none the less, fun to sit behind the wheel and imagine what driving the car would be like. I am not familiar with newer Corvette's but our group felt that the shorter front-end enhanced forward visibility and the shifter had a quicker,

shorter throw. How the car actually feels and drives on the road will have to wait till a later time but I am sure it will be exhilarating.

Manager, Roy Sinor as Judging  
Chairman, Gary Mortimer as  
Merchandising and Membership  
Manager, John Pirkle as National  
Corvette Museum Representative and  
Carlton Colclough as Public  
Relations. Terry McManmon was re-  
confirmed as editor of The Corvette  
Restorer and Eric Mortimer was re-  
confirmed as editor of The NCRS  
Driveline.

Howard Loomis has resigned as  
Youth Director after 10 years of  
outstanding service. Howard has  
gotten the young people involved in  
the judging process and established  
programs for them at our National  
Convention. Many thanks to  
Howard!

Joan Burnett, past St. Louis Chapter  
chairman, has accepted the appointed  
of NCRS Youth Director. Joan has a  
lot of great ideas on how to get the  
young people more involved in  
NCRS.

The Regionals for 2007 will be held  
at the following sites: Kissimmee,  
FL January 18-21; Las Vegas, NV  
April 12-14; Charlotte, NC April 26-  
28; Wildwood, NJ May 17-19;  
Rochester, MN June 7-9;  
Leavenworth, WA September 20-22;  
Waco, TX, October 25-27.

Two outstanding proposals were  
presented for holding the 2008  
National Convention, St. Charles,  
MO and San Antonio, TX. The  
board voted and selected San  
Antonio, TX, July 20 – July 24,  
2008. The Texas Chapter will be the  
hosting chapter and Gary Chesnut  
was elected to be the National  
Convention Chairperson.

The 2005 NCRS Road Tour has 7  
tours that plan on meeting in Price,  
UT July 16<sup>th</sup> before driving into Park  
City, UT on Sunday morning, July 17<sup>th</sup>.  
There will be a large Corvette  
parade, led by the 50-year old 1955  
Corvettes, through downtown Park  
City. We expect about 100  
participants.

Gary Mortimer reported NCRS 2004

about 11%. Eric Mortimer stated we

members.

Carlton Colclough reported NCRS  
gave a total of \$42,429 to charities  
during 2004 with \$19,727 given by  
the chapters and \$22,702 given by  
national. National will continue to

Guidelines.

John Pirkle reported the National  
Corvette Museum was pleased with  
the recent upgrade to our display at  
the museum. We will continue  
finalizing the upgrade with the  
installation of a new display case to  
highlight the various awards given  
and received by NCRS.

The NCRS Board of Directors adopted a Code of Ethics for all directors, employees, etc. It states:

- I will, as a member of the National Board of Directors, NCRS Employee, etc., regard myself as a member with an important and honorable position.
- I will conduct both my personal and official life with professionalism, truthfulness, and fairness, to inspire the confidence of the membership. My actions or in-actions will never violate good business ethics or otherwise be deemed to be dishonest, unethical or unacceptable, avoiding even the appearance of impropriety.
- I will regard my fellow board members and employees with the same standards as I hold for myself. I will never betray a confidence. I will consider all matters before the Board and its sub-committees to be confidential and will handle all matters, materials, and e-mails as such unless otherwise directed by the Board.

- I will uphold the NCRS judging standards and protect the philosophy of "the preservation and restoration of the Corvette". I will avoid alliances with those whose goals are inconsistent with the philosophy and standards of this organization.
- I will be loyal to the organization and to the members I represent.
- I shall never criticize, condemn, or otherwise denigrate a member of the organization or an employee of the organization while in the presence of other members of the organization.
- I will represent my position to the best of my ability and be totally honest with all members. Unprofessional conduct will not be accepted.
- I understand that all equipment, documents, publications, merchandise, communications and funds that are entrusted to me shall remain the sole property of NCRS and shall be returned to the Organization when my term/employment has ended. Misappropriation of NCRS funds or misuse of NCRS property will not be tolerated.
- I will protect and promote the interests of the Organization. While serving on the Board or as an employee I will not put any other automobile organization's schedule ahead of the NCRS.

The NCRS By-laws and the NCRS Registration Guidelines had some minor revisions. Additionally, the NCRS Chapter Guidelines and Operation Manual had a complete revision. If you would like a complete set of any of these documents please contact your Regional Director or Chapter Chairman.

Tom Hincz and John St Peter will head up the "Year of the 1955" at our National Convention in Park City that was mentioned in the winter issue of The Corvette Restorer. 1955 car owners that either display or have their 50-year-old car judged at the National Convention will be awarded a plaque signifying the anniversary. In addition, they will be highlighted in the road tour parade as it arrives at the National Convention. The registration form is in the latest issue of The Driveline and all of you 1955 owners should make every effort to attend.

The regional meet selection map was redrawn to further achieve better balance with geography, NCRS population and chapter locations. Our goal is still to have one regional meet in each area per year and then another one near the location of the National Convention. The regional meet selection map is as follows:

### NCRS Chapter, Regional & National Registration Guidelines\*

Registration criteria for all of our meets (national, regional and chapter) have been inconsistent to say the least. Some of the meets charged for guest, others said there could not be any guest, some vendors paid and some did not, some allowed extended family while others did not, some did not charge to view the judged cars while others did and some did not require wearing of nametags while others did.

For the past several months the Board of Directors has been working on establishing registration guideline criteria for all of us to use at our national, regional and chapter meets. After much thought and consideration the Board of Directors has now adopted the following registration guideline effective January 1, 2004.

#### Registration Guidelines

The registration fee to any NCRS meet is very important to the financial success of the event. Adhering and enforcing the registration guidelines insures that the registration fee will be kept at a reasonable amount for all of us. There are no free rides regarding registration. Everyone pays including: NCRS officers, judging team leaders, volunteer workers, and vendors. Sometimes, but infrequently, an exception is made for special invited guest.

#### Registration

All event registrants must be NCRS members.

When a member registers for an event it is for that specific individual and his/her immediate family (spouse/companion) and children under the age of 23. Children 23 years of age and older must be NCRS members and register separately to attend. Companion does not mean brother, sister, in-laws, cousin, mother, dad, mechanic or restorer. These all need to be NCRS members and register separately unless attending as a guest or extended family (see below).

Nametags should be issued at the event registration desk to all registrants, single guest and extended family. Nametags should be worn at all times during the event and there should be no exceptions. Persons should not wear or use another person's nametag.

#### Guest

Each event registrant is entitled to bring **one guest** provided the guest is **not an** NCRS member. There should be a guest fee charged and shown on the registration application equal to one-half (1/2) of the event registration fee. A person registering as a guest should be issued an event

nametag. The guest is then permitted to attend or participate in any NCRS event function. Extended use of this provision will not be tolerated.

Special Invited Guest can be issued a special registration pass, intended for NONNCRS Members, who perform a specific function at the National Convention i.e. Technical Seminar Instructor. The following three NCRS Officers can issue a special invited guest pass: Vice President/National Activities Chairman, Business/Financial Officer, and Public Relations Officer. In the event the special invited guest chooses to participate in other NCRS National Convention activities he/she should pay for the other activity/entertainment fees.

#### **Extended Family**

Each event registrant is entitled to bring their extended family (sons and daughters and their immediately family) members on a periodic basis without them becoming NCRS members. Each extended family attending the event will pay one-half of the registration fee. For example a NCRS member bringing their son and his family will pay one and half times the registration fee. A NCRS member bringing their son and daughter with both their families will pay two times the registration fee. The extended family is then permitted to attend or participate in any NCRS event function. Extended use of this provision will not be tolerated.

#### **Day Passes**

Occasionally there are times when an NCRS member can only attend one day of a regional or national event. In these cases an individual can be sold a day pass, usually \$5.00 to \$10.00, for one single day. No multiple day passes should be allowed. This day pass entitles the NCRS member to only view the cars and does not allow the individual to attend or participate in any NCRS functions such as meals, technical sessions, judging sessions, meetings, activities, etc. Day passes should not be sold for single day chapter/regional events.

Additionally, a single day pass (general admission) can be sold to non-NCRS members that would entitle the individual to view the cars but does not allow the individual to attend or participate in any NCRS functions such as meals, technical sessions, judging functions, meetings, activities, etc. Multiple day passes should not be sold to the same individual.

If the judging field can easily be secured (an enclosed facility), every effort should be made to restrict admission during scheduled judging hours. Only persons wearing NCRS event nametags or persons paying the day pass fee should be allowed to enter the judging area. Doors/gates should be monitored and day fee collected by host chapter personnel during scheduled judging hours.

Installation of temporary fencing should be evaluated for outside judging areas and large swap meets in order to restrict admission to paying attendees i.e. NCRS event attendees with nametags or persons paying a day pass fee. Gates should be monitored and day fee collected by host chapter personnel during scheduled operating hours.

#### **Late Fee**

Normally there is a late fee charged for the person(s) registering after the specified cutoff date. The cutoff date is necessary to assist the NCRS event volunteer staff in planning and preparation of the event. Nametags must be printed, registration/judging packets stuffed, judging sheets prepared, car placement and layout finalized, guarantee meal and event numbers given, etc. The late fee is charged to encourage attendees to register early so the above planning and work can be completed prior to the event.

Occasionally non-NCRS members show up at the registration desk, particularly at a national event, wanting to attend the event. In this case we charge the individual the event registration fee and generally waive the late fee if they sign up to become a NCRS member. Otherwise they can only attend via a single day pass. NCRS members registering at the desk are charged the late fee in addition to the registration fee.

#### **Public Relations**

At times we have media or press personnel requesting a complimentary pass to attend a portion of our National or Regional meets to do news articles. These complimentary passes should be issued on a case-by-case basis to view the cars, conduct interviews, take pictures, etc. These persons should not be allowed to attend any NCRS functions such as meals, technical sessions, judging functions, meetings, activities, etc. unless they are NCRS members and have paid their registration fee or have been invited by the NCRS Public Relations Spokesperson. Carlton Colclough, NCRS Public Relations, should be notified of any media or press personnel in attendance at any regional or national event.

#### **Vendors**

All vendors should be NCRS members, pay the event registration fee in addition to any swap meet space or vendor fee charged. Vendors should be issued event nametags and are allowed to attend any NCRS event function.

**NCRS is a great organization made up of great people and if we all follow these guidelines it will significantly help in maintaining the registration fee at the lowest level.**
