Chapter Meeting Notes

The Heart of Ohio Chapter of the NCRS held its second 2006 Technical Seminar on Saturday March 4th. Our speaker was Mike Hack of Eastern Corvette and his topic was “Electrical Troubleshooting”. About twenty members were in attendance.

Mike started his presentation by telling us about his background in Car Audio and then, as did Perry Yasher in February, used the analogy of water flow to illustrate the measurements of electricity such as volts, amps and resistance. He too cautioned us about letting the smoke out of the system.

Following this introduction Mike gave us a quick course on how to read Corvette electrical wiring diagrams. He started by telling us that the laminated, poster sized, electrical diagram of our Corvette, that we all know and love, was basically impossible to use for trouble

shooting. He has much younger eyes than I do and this made me feel that I am not the only one who goes cross-eyed trying to decipher a circuit in a poorly lit garage. His solution – and one of the best take-away tips from his presentation – is to take a large sheet of blank paper and draw-out the circuit you are trying to trouble shoot. He then showed us several examples of circuits he had drawn-out.

My first thought was – “That sure is a lot of extra work!” – but then I thought again. How much time do I waste reading and rereading that fool diagram – especially tracing and retracing just where a single wire in a complex circuit goes? And, a second waste of time is trying to understand how a circuit works when you can visualize only a segment of it at a time. Wow – what a neat idea – draw out the circuit so you can understand and then proceed to trouble shoot it with a large, easy to read diagram. Sure is a whole lot easier than wrestling with a large chart that you can't read and that keeps wanting to roll itself up.

Mike then talked about the tools of his trade – standard, off the shelf, electrical testing tools and accessories and special tools and accessories he has made

himself. Mike told us how he used every tool he brought, where he got it from, or what he made it out of, and what was good and bad about it. He then passed it around for us to look at. Mike also brought along a supply of Corvette electrical parts that illustrated various electrical problems he had encountered. He explained the problem with each, how he found it and how he fixed it. Then, he passed it around for us to look at.

This hands-on approach was very meaningful to me because I could look at a part and see what was wrong with it or a tool and know how to use it, or at least know what it was used for. I got several ideas for tools I wanted to buy and Mike's review of what he thought about the tool and how it worked for him really helped me. I also got a couple of ideas on simple testing accessories I could make.

In summary, this was a great learning session. Mike is a good teacher and he is very eager to share his knowledge and experience. Also, he and his dad Steve, who attended with him, very generously gave our club two gift certificates for service in their shop and invited

us all down to their shop for a club outing.

1965 Corvette Coupe

I am an NCRS member #1610

I am trying to determine the first owner (i.e. years 1965-1967) of my 1965 Corvette Coupe red int/ext 4 speed 4:11 rear gears 365hp radio tinted windows.

The Corvette vin# 194375S112826 was delivered as new car March 11/65 to Edgewater Chevrolet formerly located in Cleveland Ohio on Detroit Ave.

HOWEVER the car was sold as a used car around 1968 by V.V.Cooke Chevrolet Limited formerly of Louisville Kentucky. The second owner was a Donnie Gardner formerly of Buffalo Ky now of Elizabethtown Ky who worked in parts department at V.V.Cooke Chevrolet.

V.V.Cooke Chevrolet of Louisville was in those years one of the biggest Corvette dealers in the U.S. and bought both new and used Corvettes from other Chevrolet dealers so

my Corvette may have been either:

- (i) Dealer traded to V.V.Cooke as new car and sold by V.V.Cooke as new car
- (ii) Sold as new car by Edgewater Chevrolet & bought by V.V.Cooke as used car
- (iii) Sold by Edgewater Chevrolet & first owner moved to Ky and traded car in at V.V.Cooke

As a result I am looking for anyone who might remember the Corvette in the Cleveland Ohio area in the years 1965-1967 even if they do not remember owners name. Especially if they remember car in dealership showroom.

The States Ohio and Kentucky purged their older DMV records and so no ownership history records are available for years 1965-1967.

I have talked to second owner and a few older retired employees from both Edgewater Chevrolet & V.V.Cooke Chevrolet but no luck in terms of determining first owner name or positive confirmation which of the two

dealerships actually sold my Corvette as a new car.

Update on Randy Mullins

Lou received the following email from Michelle Mullins on March 29th.

Hi,

I just wanted to let everyone know that Randy is having Deep Brain Stimulation (DBS) surgery performed at the Cleveland Clinic on Monday, April 3, 2006. The doctors are hoping this will help with the MS tremors in his right hand and arm that have become significantly worse. They have tried Chemotherapy and several other drugs, but Randy's MS continues to get worse. They now classify his MS as Secondary Progressive. The Clinic performs DBS surgery several times a week for Parkinson patients, with good results, but have only performed a few of these surgeries on MS patients. The results for MS patients are not as good, but we are very hopeful that the

surgery will make the tremors in his right arm less debilitating.

He will spend 2 nights at the Clinic and then return later to have leads run to a battery pack in his chest and other follow-up appointments. Randy, Randy Jr. and I will drive up to Cleveland late Sunday evening so Randy will be there for his surgery which is scheduled for 6:40 am.

Randy has testing tomorrow (March 30th) at the Cleveland Clinic from 9:30 am until 8:00 pm.

Please keep us in your thoughts and prayers. I will try to update you when I have more information. I have included an article from a friend that gives more information about MS.*

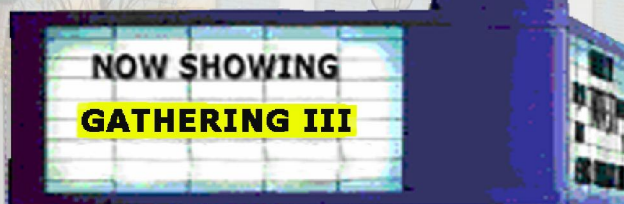
