For those that are familiar with this acronym (CDCIF), I apologize, but for those that are not aware or need a refresher here is a small synopsis: CDCIF stands for Configuration, Date, Completeness, Installation and Finish.

Each of these categories are used to judge parts of the Corvette as it should be as the Corvette left the factory. Thus, each of these categories are considered a 20% worth of the judged item. NCRS addresses Standard deductions guidelines for condition are use in the following manner. Dealer prep is a 0% deduction. Minor ageing is a 1-25% deduction. Moderate Ageing or Damage is a 26 – 50% deduction. Severe Ageing or Damage is a 51 – 75% deduction. And Missing items are a 100% deduction. To help our members remember these guidelines the NCRS has published a small

guideline handout that you can obtain by asking our Judging Chairman, Mike Treece.

Collection is incredible and about a 3 hr drive from Columbus.




