### Annual Chapter Fundraiser—LifeCare Alliance (Meals on Wheels)

LifeCare Alliance is a 501c(3) nonprofit that delivers **5000 meals per day** in 5 counties. LifeCare Alliance is funded solely by donations and prepares all of the meals in a large kitchen in Columbus, Ohio. They also serve seniors dinner, take people to the hospital, and a host of other programs to help those in need.

In the past, we have donated the monies from Cars and Coffee as well as \$500 from the Chapter. The National NCRS has a matching gift program of 50% of the Chapter donation with a \$1,000 maximum.

This year, the Heart of Ohio Chapter Board voted to donate \$500 for this worthy charity. As we could not do our fund raising event, we would like to ask our membership to see if they would like to donate. We will hold open the donation period to October 17, 2020 at our next Chapter meeting. If you would like to donate to our selected Charity, we have outlined a few options for your consideration below:
