Not so technical, Tech article

I recently Purchased a 1984 Corvette from the original owner's estate in Fairfield, Ohio. Initially I found the car to be one in very good condition and opted to offer a bid that was reasonable, given the deficiencies that I found. One, there was no front license cover. Easily solved by Ecklers for \$30.09 including shipping. The delivered cover was clear and therefore a quick trip to my favorite body and paint shop ended with a Bright Red cover, painted from the inside and then clear coated. Another \$30.00. That should eliminate road dust and gravel chips. Next up was the absence of a head liner.

I took the car to a local upholstery shop where I received an estimate, not in writing mind you, for over \$500 to create a hard backing, make a material cover and reinstall in the Targa Top,

I called Mike Yager at MidAmerica and told him of the dilemma and he said that he had a perfect solution. A hard backing with the headliner material already glued in placed and all I would need to do is purchase some adhesive or Velcro and install it myself. Total price delivered \$157.99. Thanks to a few YouTube videos, the process was simple. So, off we go.

First up is the removal of the Targa top. That my friends turned out to be no easy task. At least not on this 84 Corvette. While the video showed the removal of 4bolts, it actually turned out to 8-bolts. Two in front under the sunvisor and six in the rear. Two for the top and (4) for the brackets. In the videos, no one spoke of or addressed the brackets. So, I removed 4-bolts that were normally necessary, but the top would not come off without removing the other 4-bracket bolts. So here's where it get's interesting. There are 4-main bolts that hold the Targa Top in place. After I removed the 4 main bolts, what I discovered is that there are 4 other bolts that hold on the rear brackets that hold the rear mounting to the top. After removing 4-additional bolts that continued to hold the brackets in place, I discovered that somewhere along the line, the previous owner had replaced at least one of the bracket bolts that was 1/4 " too long. That one bolt was holding the top in place as it had been tightened to the point of resting against the vehicle hard top at the rear. Once all of the bolts were removed, the lifting off and on was easy.

So, the dilemma was simple, replace the bolt with an original size. Done, readily available at your local Chevrolet dealer.





Once the top was removed the new headliner easily slipped into the allowed space and with the aid of new Velco strips held in place and stayed as designed. Once accomplished, I replaced the brackets using the correct bolts and lifted the top back into place, sliding the rear portion in first and the front easily settled into the front receptors and using the factory rachet, I tightened the 4-main bolts back into place and turned on the water hose to check for leaks. No leaks and the interior looks a lot better.

At the end of the day, one little bolt that was 1/4" too long caused additional time, a little anxiety and a quick shopping trip. Careful what you think you know, because sometimes you just don't know, what you don't know.
