Heart of Ohio Chapter NCRS – Heart Award Program

Points will be awarded for a Chapter member participating in the following Heart of Ohio Chapter events:

7 points	Write a tech article for the Chapter Newsletter. (One tech article for credit per member in a calendar year)
5 points	Register and participate in the Chapter Judging Meet. (Have your car judged or registered as Sportsman at the meet for 2 additional points.)
5 points	Attend and Drive your Corvette on the Chapter Road Tour.
4 points	Host a Chapter Event.
4 points*	Work at the Chapter Charity Event.
3 points*	Attend the Chapter Picnic.
3 points*	Attend the Chapter Holiday Party.
2 points*	Attend a Chapter Judging School.
2 points*	Attend a Chapter Meeting.

* Drive your Corvette to one of these Chapter events and receive an additional 2 points.

- Points are accumulated from January to December of the current year.
- A Heart of Ohio Chapter member who accumulates **15 points** in that time frame will be awarded the following based on their award year sequence.

Year One Award - Red Polo Shirt Year Two Award – Red Hat Year Three Award – Black Jacket Year Four Award – Chapter Pin Year Five Award – The Heart Beat Award Plaque with space for additional award years displayed

The awards will be presented at either the January or February Chapter in person meeting of the following year.

- The Chapter Secretary will be in charge of keeping records of participation for award purposes and ordering the awards.
- The Chapter Treasurer will be in charge of paying for the awards.
- Cost of the awards will be funded by the Chapter.
- Clothing awards will be purchased through the Chapter's Lands' End account or other quality vendor.

There were 132 attendees from Canada and America. Mike is providing a service for NCRS members across the county to obtain information and training that would not be available to them locally.



Florida Regionals— February 23-25, 2023 By: Fred Richards



The Florida Regionals are a great place to be in February. The three days of the meet Florida was having temperatures in the high 80s and sunny.

After flying into Orlando, I made a sunny drive to the Sun n Fun center in Lakeland. I made it just in time to be an observer judge for the C4 operations. It was a very busy time judging six C4s. I worked with George who is the first five star judge. I was very open to teaching the judging methodology.

At the end of the afternoon a session was conducted on Corvette Frames for 1953-1962. The part of the presentation that I found interesting was the descriptions of the RPO options that centered around the brakes. The options where placed in a box in the trunk. It was a dealer installed option. Only a few cars were delivered with the RPO options. The presenters emphasized that the cars were to be judged as delivered by the dealer. I found that statement enlightening

since I had always been told that the judging was to be as delivered from the factory.



The maroon C4 above is a 1989 ZR1. They did not make very many '89 ZR1. Rumors are they made about 90 cars. It is commonly thought that the ZR1s were only made from 1990-1995. On the right is a challenger car. NCRS has a special category for these cars. It was great to review one in person.

I spent the day as an observer judge judging the interiors with Pete a 400 level judge and Joe a master judge. It was a great experience to spend the day with them.
