I recently returned from the 2025 NCRS National Convention in Las Vegas and want to report it was a terrific event again this year. There was 117 Corvettes on display in the ballroom to be judged for various National awards. The Southpoint Casino and Hotel is a beautiful location that looks like new but actually was opened in 2005. As planned, I met several new Corvette friends from all over the USA and had a great time, learned from many talented Team Leaders and fellow NCRS Judges.

My main objective to attend the Convention was to learn more about the NCRS declining Membership issues and have an opportunity to talk with the NCRS Officers and Board about their plans to grow the membership. My understanding is that total membership is still overall declining but some chapters are doing better than others. It appears the growth in Flight Judging is from the C5 & C6 corvettes. The Flight judging of C1-C4 cars appears somewhat stable but not growing. There was some discussion about members that only pay dues to get the magazines and are not active or involved in activities, judging or even Chapters. My opinion on these "Pay Only" members is that if dues continue to increase, they will drop out and NCRS will lose the revenue from their dues.

There was an announcement that the Concours Program will be going through a major overhaul with the intent to at-

tract new members with late model Corvettes into NCRS. The new program is being named the "Open Division" – meaning NCRS is opening the door to all Corvettes being restored, preserved and recognized by NCRS for future generations. Effective as of October 2025, there will be cars up to C8 Corvettes invited and judged at the NCRS Texas Regional Judging meet. The classifications in the new "Open Division" were announced as having Stock & Modified classes but another class is being discussed to join in the Open Division. My suggestion to Officers Mike Igram and Tony Stein was to create a Custom/ Restomod class.

The Flight Judging Program remains as the foundation of NCRS with the Classic Blue Ribbons awarded to the Top Flight Cars. The new Open Division will not have any Ribbon awards and will change to award plaques of some kind for Top Class cars.

With these new changes, there likely will be more information in the coming months to answer questions from the Chapters and membership. But I am in favor of the Open Division Program, and it should provide the Heart of Ohio with some opportunities to grow our membership in Ohio.

In closing, I want to thank Mike Treece for organizing some excellent activities this past season, including the Covered Bridge Tour with Mike Cappozzio. The picnic venue was outstanding at the CJ Brown reservoir, and the Champaign Aviation Museum tour was very impressive! Thanks to all that helped at another successful Charity Fundraising event in Lancaster, Ohio.

Champaign Aviation Museum— September 20




