<u>Tech Article – Speaker Refurb</u> Dino Lanno

HoO member Dino Lanno has put together a nice article on restoring a speaker on his '62.

<u>Restoring an original 1962 Corvette</u> <u>Speaker</u>

I was doing a frame off on my 62 and had the windshield off and was replacing the dash pad and removed the speaker for restoration, simple 4 speed nuts screwed into the 4 bosses of the speaker bezel with a perforated stamped metal screen between the bezel and the speaker frame....the speaker itself has a dust cover that was black and faded and as you can see in the picture the speaker cone is torn and dried...I sent the speaker assembly away for a new cone, voice coil and dust cover, and to be tested.

If you have an original Delco speaker, my suggestion is to contact Jackson Speaker Service and have your unit rebuilt. The non-moving basket and parts may not be pretty due to age, but they will still work just fine once the paper cone and voice coil are replaced. The cost was \$70. Be aware of part distributor replacement speakers and ebay specials, they will damage you radio if you do not have the proper specs on impedance. Ron was a great guy to work with, 2 week turn around.

<u>Tech Article – Reprint on Paint</u> Judging- Lou Zuniga

NCRS Paint seminar

Background reason for changes in automotive painting systems:


Paint has been a controversial point of discussion for NCRS judges for many years since base coatclear coat paints have taken over the automotive paint industry. Lacquer paints were replaced by catalyzed paints since lacquers cure by evaporation of volatile toxins chemicals during the curing process while base coat-clear coat paints catalyze in curing by cross linking polymers and they also provided a much more durable paint system.

During the winter Florida regional David Brigham and Tom Ames presented a paint seminar to introduce a new version of paint judging guidelines. David and Tom began by a short history of General Motors painting systems evolution.

"From 1953 through 1981 model years Corvette bodies were originally painted in lacquer. Corvettes from model years 1982 through 1999 had bodies originally painted with a base coatclear coat system"

This is in reference to the image viewed in the paint when light is reflected back from the painted surface. Lacquer will reflect back an irregular image such as a light that reflect back similarly as a wash board effect (Orange Peel). NCRS has typically been using the following flow chart as a guideline for judging Corvette paint.

NCRS Paint Flowchart



David and Tom referred to the following to use as the judging guide

Distinctness of Image (DOI)

Texture

Surface Irregularities & Edge Build-up (or lack thereof)

Contaminates visible in clear coat

Distinctness of Image (DOI)

Do not confuse DOI and Gloss

An irregular surface can be highly polished, but still have low DOI

Whereas base coat-clear coat will reflect back a clear image with very little to no wash board effect (Orange Peel). Not to confuse DOI with gloss as discussed in the next slide presentation.


So, in the current guideline method of judging, we move on to a second step to answer.

Step 2: After Material Question has been answered

> We move to the Method Question

You must select one of two options

Again referencing the current guideline chart:



Thus based on the left side of the chart at most 20% deductions would be realized.

Assume that the Answer to Question 1 is **YES**

What are my 2 options?

If appearance **IS** consistent with Factory Application Method, deduct zero.

If appearance is **IS NOT** consistent with Factory Application Method (over/under restored or paint in unusual areas), deduct 20%

So, if the answer to the question: "Does the body paint material appear similar to the factory applied material (doors, hood, trunk closed)?" **NO.** Then the right side of the paint guidelines flow chart is used. Thus a 50% to 100% deduction is realized.



Does the Body Paint Material appear similar to the Factory Applied Material? (Doors, Hood, Trunk closed) VES Is the Appearance consistent with Factory Application Methods? (Over/Under Restored or Paint on trim or weatherstrip) Deduct 0% Deduct 20% Deduct 50% Deduct 50% Deduct 100%

At the Florida winter regional a new guideline Flow chart was introduced. This time the right side of the guideline Flow chart has been modified to allowing more leniencies in the paint guidelines.

PLEASE NOTE: These guidelines will not be use until after the National NCRS judging meet (sometime in August 2016).

NCRS Paint Flowchart



As explained in the seminar: "What is the revised question? When the answer to the first portion of the question is No" "Does the painted exterior surface exhibit <u>Attributes</u> consistent with factory applied methods?" What is mean by the **ATTRIBUTES?** Look at the exterior finish with doors, hood and trunk

closed. Look for attributes that would be noticeable on a factor finish. That is Moderate DOI such as Texture (Orange Peel), Less coverage in lower areas of the body, and Less buffing in lower body areas.

How do you score Paint Originality if you don't see factory Attributes?

Deduct 70% if the Jambs, Hood and Trunk ledges are less shiny than the exterior body.

Deduct 100% if the Jambs, Hood and Trunk ledges are as shiny as the exterior body.

(Hair Spray Rules apply here)

Why is NCRS waiting until August 2016?

- 1. To allow owners and restorers ample time to transition to the new guidelines.
- 2. To properly train our NCRS judges.
