"1953 Corvette's...VIN #58 and VIN #175"

A little background on the two 1953 Corvette's to be judged on April 19th & 20th at the Oklahoma Chapter meet.

Vin #58, unrestored, the car history comes from the widow of Jack Myers. A friend Told her that Jack, who worked for GM after graduating from high school, was the 2nd owner and had purchased the car from a doctor in Michigan. The car was eventually stored in Michigan, and moved several times in Tennessee where Jack moved after his retirement. Another friend said the car was in storage in 69/70 and was always garaged. When purchased in 2014, we believe the car had not been running for several decades. This Corvette was born approximately on October 6th 1953.

VIN #175, 2nd restoration, the car history has a unique background starting with the Vin plate. The car was purchased by Dr. John Mansell on December 9th 1967 for \$895, with the speedometer reading 43544 miles in Ohio. He saw an ad in the Youngstown Vindicator for a 54 Corvette, which was sold with no Vin # for more money claiming it was a newer car. Dr. Mansell did some research and recognized that the car was a 53 model. Two General Motors employees were summoned by Dr. Mansell and verified that his 53 Corvette was truly Vin # 175 and was issued a GM corporate Vin plate with a certified letter stating as such. Dr. Mansell proceeded to spend several years restoring the car before entering it in numerous "Classic Corvette Club 53-55" judging events which was established in August 1970. In 1972 this car won 1st Senior Class division in Flint and Troy Michigan and "Best of Show" and 1st Senior Class at Columbus Ohio in 1973. Dr. Mansell documented as many 1953, 54, and 55 Corvettes he could verify in a hand tabulated spread sheet but concentrated on the 53. He added an additional 24 to the 107 known 53 Corvettes identified in the 1972 Corvette News Dec/Jan edition by P.J. Joe Pike. Dr. Mansell's Corvette was recognized in the 1970 Corvette News Dec/Jan edition with a sterling silver fascia plate which was part of the "1953 Corvette Honor Roll" displayed in Chevrolet's central office. The Corvette Vin # to engine # is identified in Noland Adams "The Complete Corvette Restoration & Technical Guide - Vol. 1". Dr. Mansell also possessed many letters from Sam Fotz, John Hutchins, Noland Adam's and many others along with a letter dated June 2nd 1972 by Chip Miller stating "your '53 is the finest I've seen". This Corvette was born approximately late November 1953.








