# 10 More Incredible Corvette Facts Most People Don't Know!

Corvette Forum By Joe Kucinski - July 11, 2023

A couple of months back, we *(Corvette Forum)* shared a list of ten Corvette facts that you likely didn't know. But with 70 years of history to pull from, the list is far greater than just ten. There are dozens of facts, and stories involving the Corvette that are likely to surprise and/or amuse you. So, with that in mind, here's another list of ten Corvette facts that might be a bit obscure but entertaining to any Corvette enthusiast. How many of these did you know?

### 10. Convertible Corvette History

For the first ten years in Corvette history the car was only available as a roadster. If you love open air driving, then the Corvette was your car. But a true coupe was not available until the 1963 model year. But then the convertible went away entirely for a decade between 1975 and 1985. T-Tops were available, but a true convertible was gone from the range that started out with nothing but convertibles. Then in 1986 the convertible model returned and has been a popular configuration ever since.

### 9. 2009 ZR1 Hits 200 MPH

The 2009 Corvette ZR1 made an astounding 638 horsepower thanks to its supercharged LS9 engine. And the horsepower rating was not the only eye-popping number that the 2009 ZR1 was capable of producing. It was the first production Corvette to be able to top 200 mph. For some context, neither the Porsche 911 Turbo nor the Ferrari F430 of the day was capable of reaching this speed.

## 8. \$3.85 Million – Most Expensive Corvette

There are a number of extremely valuable Corvettes out there. Rare race cars, or limited-edition Corvettes can be worth over a million dollars. But the top dog when it comes to Corvettes is the 1967 L88 Coupe that was sold at Barrett-Jackson a number of years ago for \$3.85 million. Only 20 of these cars were ever built. These were sold as street cars but were really thinly veiled race cars. GM rated the engine at 430 horsepower, but the true rating was closer to 560. The car sold at auction had an impeccable history and records to justify the extreme price.

#### 7. Astronaut Special: One Dollar Corvette Lease

There was a time that you could lease a brand-new Corvette for a year for just one dollar. The catch was that you had to be an American astronaut. General Motors President Edward Cole presented astronaut Alan Shepard with a brand new, 1962 Corvette to acknowledge his bravery as being the first American astronaut to surpass the atmosphere and successfully return. After that Jim Rathmann, who owned a Chevy dealership worked out a deal with GM to offer astronauts a \$1 a year lease program. As you would expect most took advantage of this deal and the Corvette would become forever linked with astronauts. The deal is no longer in place today but the connection between the two remains strong.

### 6. One Millionth Corvette Falls into Sinkhole

On July 2, 1992 the one millionth Corvette rolled off the assembly line. It was a white convertible model. On February 12, 2014 it fell into a 30 foot deep sinkhole that opened up below the floor of the Corvette Museum. The one millionth Corvette was one of eight special Corvettes that were swallowed by the sinkhole that day. Thankfully the event took place around 5:30 in the morning and no one was inside the museum and no injuries were reported. About 19 months after the event the one millionth

Corvette was fully restored and proudly back on display. Two other damaged Corvettes were also restored. A special window has been installed in the museum that allows visitors to look directly into the sinkhole.

### 5. Ford Thunderbird Saves the Corvette

The 1953 and 1954 Corvettes were sales flops. They were expensive and didn't have the performance to back up their sporty looks. GM was considering scrapping the whole Corvette program... Until Ford revealed the new Thunderbird at the Detroit Auto Show in February 1954 and it smashed the Corvette in sales. The story goes that GM execs were not going to let Ford dominate the market like that. So, instead of being killed off, the Corvette got a V8 engine in 1955 and the rest is history.

# 4. GM Exec Crashed C7 ZR1 Pace Car Before IndyCar Race

Any time you are having a bad day or make a blunder at work just think of poor General Motors executive Mark Reuss and you will likely feel a whole lot better. Reuss had the honor of driving a \$123,000 2019 Corvette ZR1 Pace Car at the IndyCar Detroit Grand Prix in 2018. That honor quickly turned to shame as he lost control of the car on the pace lap and smashed it into a wall sending debris all over the racetrack. Thankfully the only injury was to his pride, but the car was destroyed, and the race was delayed by nearly a half hour.

### 3. 1979: Best-Selling Corvette Model Year

One of the slowest Corvettes in history happens to be the most popular. In 1979 the base Corvette made 195 horsepower and the optional L82 made 225 horsepower. That was the most powerful Corvette you could get in 1979. It was good for a 0 to 60 time of 6.6 seconds. Not exactly an earth-shattering performance. However, thanks to emissions standards, no cars were at the top of their performance game in 1979. Despite the lack of sizzling performance folks loved the 1979 Corvette. A record 53,807 Corvettes were sold for the model year. Only one other time in history (1984) did more than 50,000 Corvettes sell in a single year.

### 2. Longest Continuously Produced Sports Car

No other sports car has remained in continuous production for as long as the Corvette. 2023 marks the 70th anniversary America's sports car. By comparison, another iconic sports car, the Porsche 911 is ten years the Corvettes junior having been released in 1963. That is simply an incredible feat for the Corvette. It has now moved the engine to the middle and hybrid power is here with full electric almost certain to follow. But through all the changes the Corvette has continued to offer thrills to sports car buyers for longer than any other model.

### 1. Twenty Time Indianapolis 500 Pace Car

The Corvette was the pace car for the 1978 Indianapolis 500. It was the first time since the inception of the race in 1911 that the Corvette would be the pace car. It would not be the last. In fact, a Corvette has now been the pace car for the great race twenty times. Including eight of the last ten races. The Corvette has been the Indy 500 pace car more times than any other car in history. The Camaro ranks second having been the pace car nine times.

#### Strengths:

It is one thing to ask for leadership from the national Board of Directors for leadership in growth and development, but local chapters also have a big part to play in developing growth.
- 3. Marketing. I support active marketing of the NCRS and its judging awards to the general collector car population. I believe that added marketing will not only lead to attracting new members, but it will also enhance the perceived value of our NCRS judging awards. For instance, the most impressive award for any restored C2 Corvette is a Duntov Award; yet, many people in the collector car hobby outside of the NCRS believe that a Bloomington Gold award is more prestigious. It is not. By doing a better job of promoting our awards, the value of members' cars with our awards will likely increase.


