## Automotive Cleaning/Drying Solutions

By Gary Mion If you are looking for something stronger thinner than a rag and much

stronger than a paper towel, check out <u>microfiber</u> <u>cleaning cloths</u>. I have used these to clean the underside of all my cars, including my '60 when I was using alcohol to remove years of grease, oil and dirt from the bottom of the body.



The structure of the microfiber cloth makes it as durable as a towel, but has the shape and flexibility of a paper towel. It is absorbent as well, and does a good job of holding a good deal of cleaning solution .My favorite is to use a 70% alcohol solution, which is an effective cleaner and dries relatively quickly.

For drying my car after washing, I really like microfiber <u>waffle weave towels</u>. They are soft and absorbant. I generally use two towels: one for initial drying (that gets wrung out frequently), and another for finish dry-

ing. I usually get 3-5 dryings before I relegate the initial drying

towel to shop clean-up duties, and the final dry towel to initial drying towel, They are still effective as towels, just not as soft as they once started out to be. Can never have too many shop towels around.

Over the years I have used <u>Microfiber Wholesale</u> as the place to get either of these towels, but there are places you can check out on the web. Maybe you have a favorite you would like to share with the Chapter members.




The remaining road tour participants arrived by 12: 30 PM.








C8 Corvette Lifting Issue & and Solution By Ed Vignone

n the early production of the C8 Corvette there were a number of Two

Post Lift accidents (Figure 1). These Two post lifts are equipped with 4 lifting arms. A number of these lifting arms were positioned 🗰 in the incorrect place on the Corvette side Frails which caused the accidents.

As you look at the side rails there are a number of locations where the fiberglass is routed around a round hole or a oblong hole in the side rail. The proper locations in the side rails for lifting are the most forward and rearward oblong holes (Figure 2).

The other holes along the bottom of the chassis rails, I assume were used in the manufacturing process.

Those accidents could be avoided if on the chassis there were well identified lift locations. To lift my previous Corvettes (C5-C7) I had a lifting pad on my jack that would only fit into the oblong hole. (Figure 3).

In searching for a method to insure my Corvette would be lifted correctly, I found that there were Jacking Pucks that could be permanently installed on the rails of the C8. I hadn't heard of a puck since a character in William Shakespeare's play, A Midsummer Night's Dream and those used in Ice hockey. In researching this article found that early use of Hocky Pucks were used to lift the body off the chassis for off road vehicles.

(Figure 3) which were used with floor jacks and not likely used on Two Post Vehicle Lifts. Lifting Pucks that can be permanently attached to the Corvette are available and come in a variety of bright colors (Figure

4). I bought 4 pucks for \$33.59 from Amazon. Search for **"Samman Cor-**




Fig.6: Puck Turned 90 degrees

vette Jack Pucks Billet Aluminum Jacking
Puck". There are other supplier with similar products which would also work. The pucks came with stainless steel cap
screws. I checked them out with a strong magnet and they only had a slight attraction as should be for stainless.

To install, screw the socket head cap screws through the puck into the threaded bar (Figure 5). Insert the bar end into

the oblong hole turn the puck 90 degrees. (Figure 6). Secure with the provided hex wrench (Figure 7). Do this for the remaining 3 pucks in the most forward and rearward oblong holes in the side rails. Put Loctiite Threadlocker Blue on the threads and tighten securely. In the future, to insure that some first day employe at a garage doesn't make a mistake I created a label for each puck (Figure 8).

## C6 Battery Cable Replacement By Garry Mion

Many years ago the positive connector on my 2008 battery harness needed to be replaced due to prolonged exposure to acid vapors from a defective battery. Essentially the connector disintegrated to the point where it was no longer able to keep a tight grip on the battery post.



The solu-



tion at the time was to cut off the connector, strip back the wires, and install a universal connector as shown on left.

After a failure of the connector (carbon build up that resulted in a no -start condition), I decided to place an order for a completely new battery harness. This was in May of 2021. However, nobody had them in stock. I took a chance and ordered one from Amazon, hoping that sooner rather than later it would again be back in stock.

Fast forward to February, 2023, I received a notice that the harness had shipped. So much for sooner.

The new harness was mostly configured like the original, except for the negative side connector. The picture at right shows the difference, where the original connector has a 90-deg configuration while the new connector does not. This rendered the negative post cover useless, and thus makes the changeover quite obvious. I'm not sure as to why this change was made.



The pictures below show the original cable label, dated 08-09-07, and the new label dated 10/20/22. However, the label is not visible when installed in the car and the battery is in place.

The replacement of the cable was straight forward, but does require that you remove the starter in order to get at the negative side cable mount to the engine block. It also makes it easier to re-



route the cable. Having access to a lift will definitely help make the job go smoother.

The GM part number for the cable is 20835504. When I originally purchased it via Amazon in 2021 it cost \$72. Now it is upwards of \$125+.

## 1956-57 Soft Top Rear Latch Rebuild

The soft top rear latch assembly on 1956-57 up to VIN 4500 Corvette are unique. These 'early' latches have not been available as a reproduction. Later latches are available. The difference is the earlier ones have a stud integral with the assembly for attachment to the deck lid. The later ones use a Philips head screw to attach them to the deck lid.

I had looked for the early latches in good enough condition to install and use on my car. The ones that I received were always a disappointment. Ones from EBay were broken, bent, rusted, or poorly repaired, and others I received were rusted and broken. The originals were riveted with solid steel rivets. I saw a couple that were repaired using nails and were loose and bent.

The latch is made of three parts that are assembled with six rivets. There is the deck plate, the closing finger, and the handle. With time and rough use, the latches wear out. The handles are usually bent and the closing finger rivets are broken. The holes at all the rivets are elongated. After looking at the construction, it appeared the latches could be disassembled, plated, riveted with aluminum rivets, and reinstalled. That is what I did and I want to provide these guidelines for your restoration.

Paragon has a latch rebuild kit #4105K that includes a new closing finger and this may be a good way to go for a new part, but it does not address the rust, bending, and other issues.

The first thing is to get a pair that are not rusted beyond replating, and not bent past a point that they can be straightened. From looking at several latches, it appears many owners have an issue with how to use the latches. There is the catch assembly that is installed on the rear of the soft top. When treating the latches roughly, the catch assembly is installed into the latch finger, then close the latch by pushing down on the latch handle. The latch is not strong enough to pull the bow to the deck lid, and eventually the latch will bend or break. The correct way is to push the rear bow of the soft top onto the deck lid and close the latch handle.


Maybe the latches can be plated as an assembly, but I disassembled mine into three pieces. The rivets were in really bad shape. The rivets will need to be removed and discarded. I left the short leg brackets on the closing finger as those rivets were not significantly worn. See the photo. Then the parts were sent out for chrome plating.

For rivets, I used aluminum rivets: 5/32'' dia. X  $\frac{1}{4}''$  and 5/32'' dia. X 0.80''. I had to buy a box of 500 of the longer rivets. I could not find a small quantity. They are 5 cents each, so maybe I will go into business? Some of the holes in the latch assembly will need to be drilled out to 5/32'' as the rivets that were originally used were different diameters. You may also need to drill out the holes if they have been elongated.

First the closing finger is riveted onto the handle. After riveting, these rivets may

need to be cut shorter so that there is no interference when operating the latch Then the longer rivets are installed. The rivet that is inserted through the handle will need to be cut with a Dremel because there will be interference.

There was some manipulation of the parts to get them to line up for assembly. The final results are worth it. Also, these newly rebuilt latches closed the entire way. The finger was close to the deck plate. I have not seen that on any other used latches. For hardware, the studs on the original latch assemblies are #12-24 thead. You will also need a flat washer and star washer.

We will be getting our kicks on Route 66 as we wind thru the USA, on as much of the old Route 66 as possible. We will be staying in some historical Route 66 Motels.


Our San Diego family will depart our area on Monday, July 17th arriving for our first night in Seligman, Arizona the "Birthplace of the Historic Route 66".
